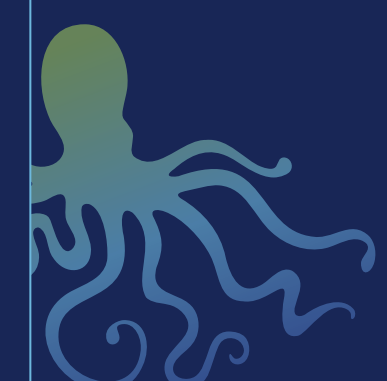

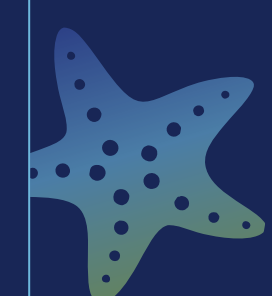

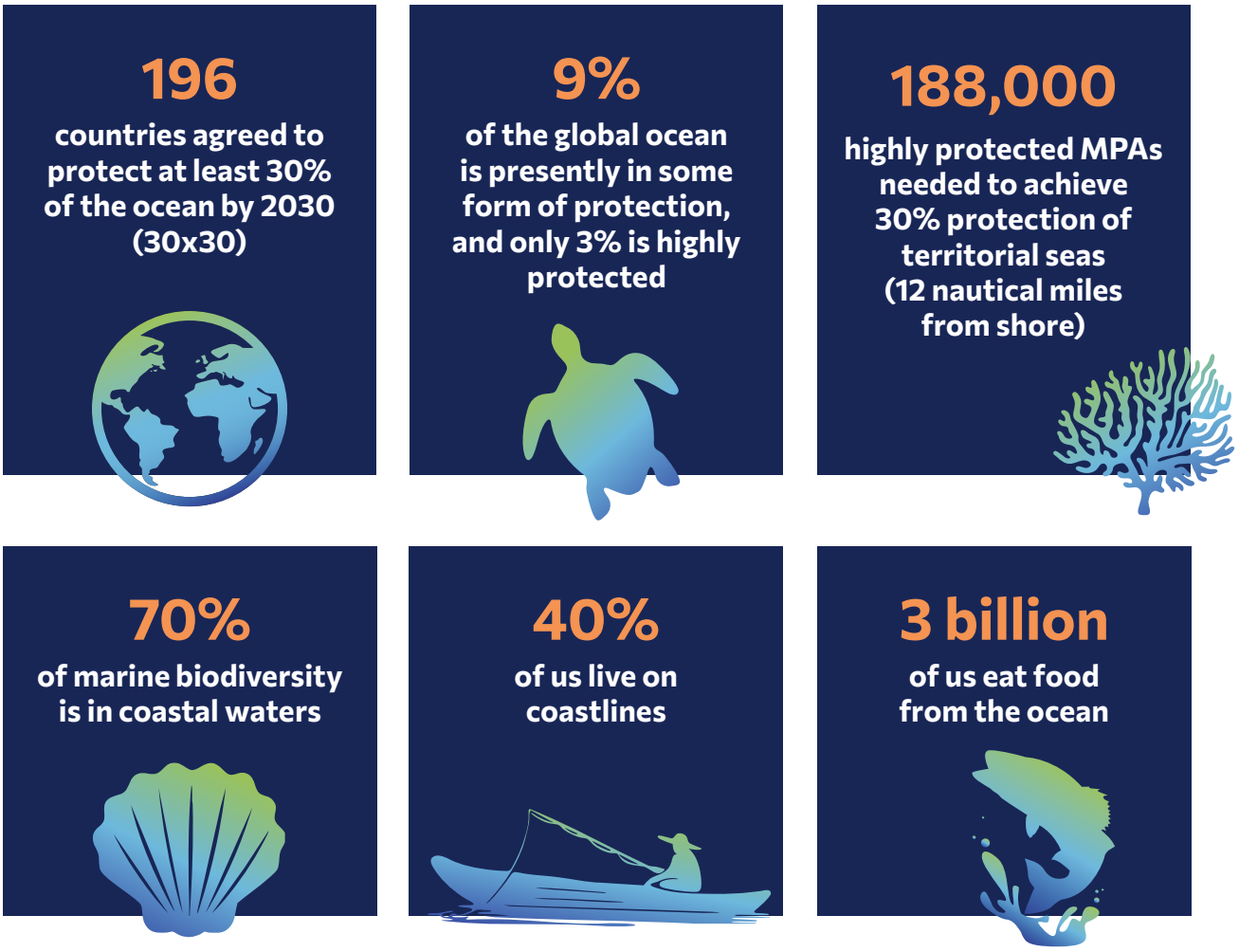
**Our vision:** Every coastal town has its own marine protected area (MPA), bringing marine life back, directly supporting tourism and fishing, and the local people who depend on it.

**Our mission:** To help coastal communities create or improve marine protected areas as local regenerative businesses.

**How did this all come to be?**

## 30X30: A GLOBAL COMMITMENT

The world agreed in 2022 to protect at least 30% of land and ocean by 2030 (30x30). By achieving 30x30 we rechart humanity's course. Protecting coastal waters is critical.



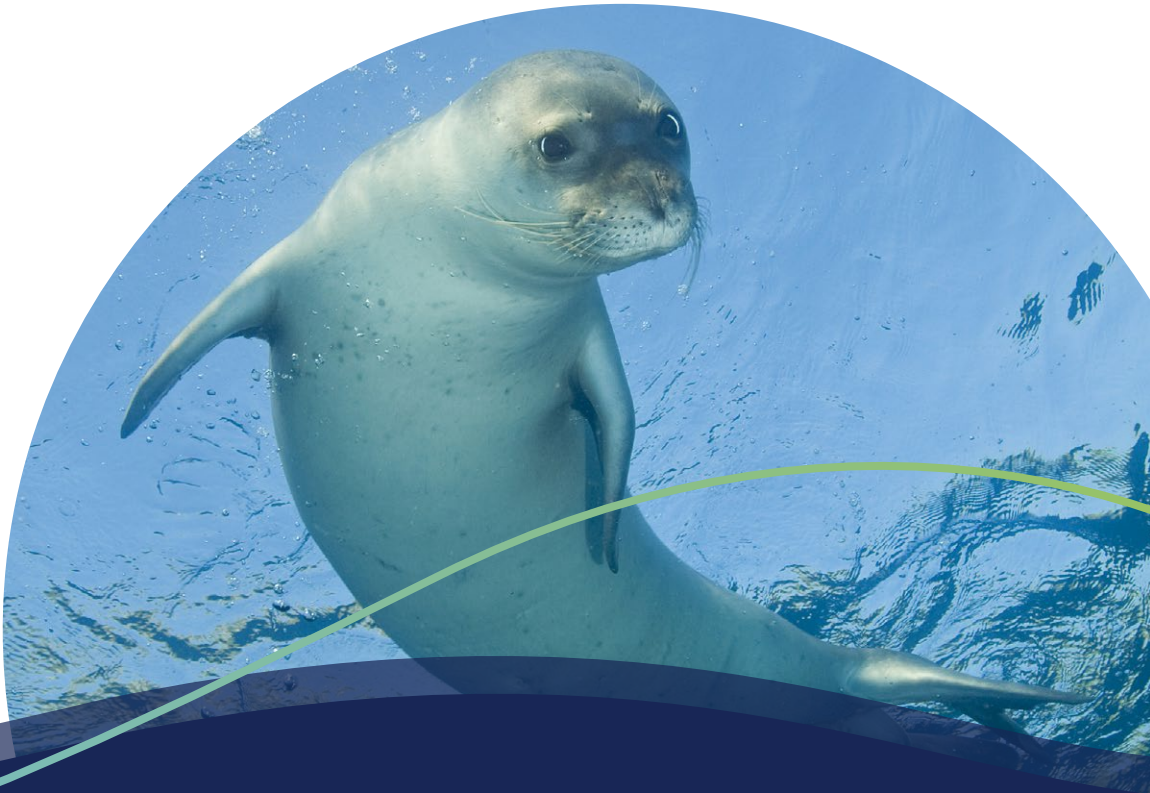
## ORIGIN STORY

Over a decade of work across the globe, Dynamic Planet witnessed a powerful fact: when the ocean is fully protected from extractive activities, it recovers faster than we ever imagined, and communities benefit with better fishing, more tourism, and more economic revenue. Well-managed MPAs are one of the best examples of “businesses that restore nature,” Dynamic Planet’s main tenet. However, the number of fully protected areas remains

very low, and most think of them as a luxury or a cost, rather than opportunities to develop profitable conservation businesses.

Why haven’t successful MPAs been replicated everywhere?

We created Revive Our Ocean to help accelerate and scale coastal conservation worldwide and fill a massive gap to reach 30x30.



## APPROACH

We learned that there are three main roadblocks — and therefore three main solutions — to scaling coastal marine protection:

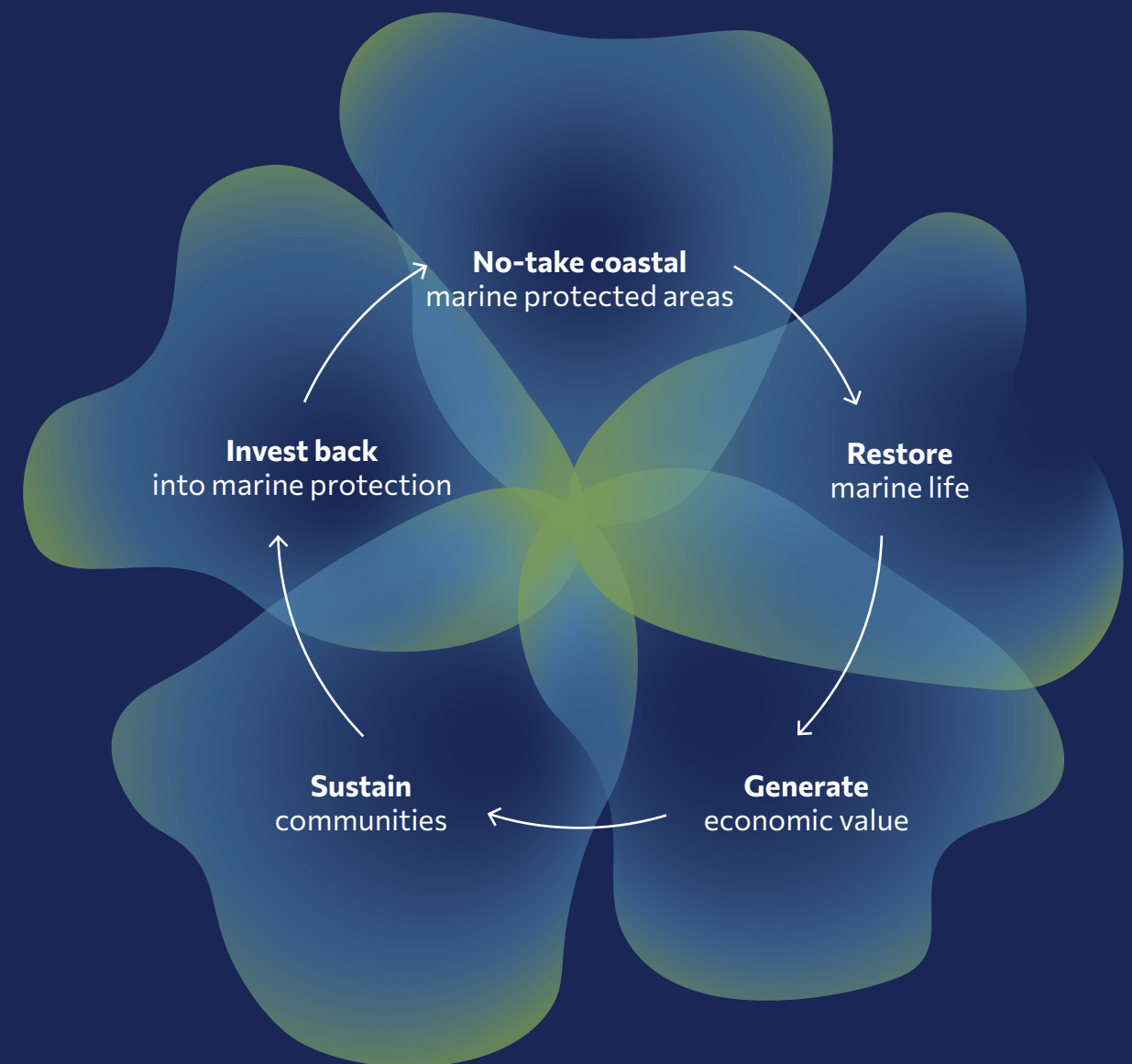

### Greece

Today, Gökova Bay is Türkiye's richest coastal area, with a 300% income increase for 90 local fishing families within only four years after protection. MCS is now guiding marine protection efforts across the country.

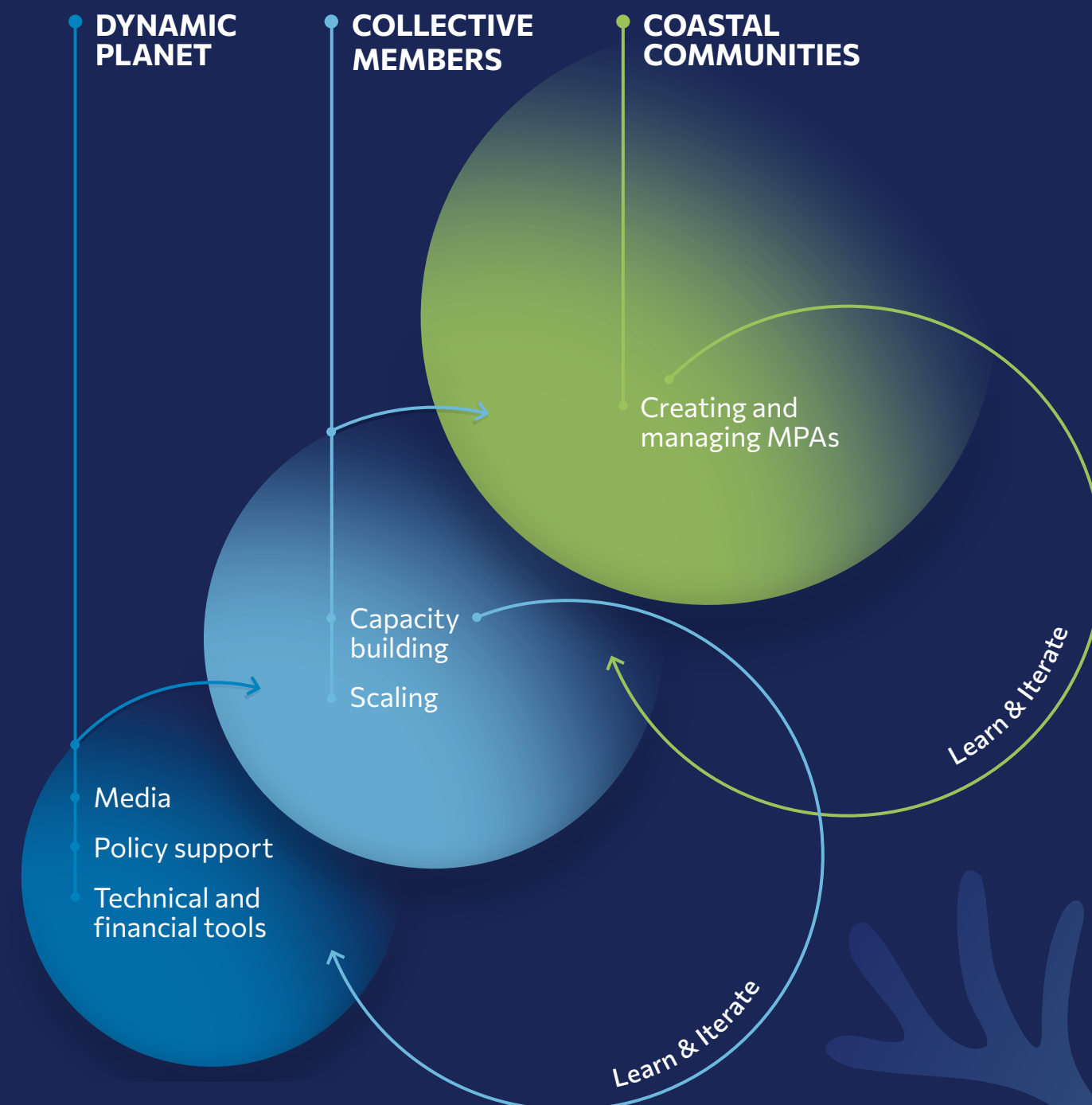

# **SPOTLIGHT: GREECE**

An example from the Mediterranean  
where **fishers are leading** the  
protection of their coastal waters



## LOCAL LEADERSHIP, NATIONAL MOMENTUM

Prime Minister Mitsotakis was the first leader in Europe to commit to phase out bottom trawling in MPAs by 2030. He announced this at Our Ocean Summit in Athens in April 2024. On October 3, 2025, this commitment was confirmed again at the launch of Revive Our Ocean — Greece, with a special screening of *Ocean with David Attenborough* in Athens, co-organized with National Geographic Pristine Seas and the Cyclades Preservation Fund (CPF). PM Mitsotakis joined fishers, scientists, policymakers, and civil society, stating “by protecting our seas and managing our resources wisely, we can not only preserve nature but also create new opportunities for the people who depend on it.”

From Athens, we traveled to the island of Amorgos to celebrate Amorgorama, a pioneering, fisher-led initiative that resulted in the creation of 3 new no-take MPAs. During an event in the port of Aegiali, PM Mitsotakis committed to expanding this approach

nationwide, recognizing the strength of leadership coming directly from the island’s fishing community.

That same evening, CPF hosted a community screening of *Ocean with David Attenborough* and Revive Our Ocean short film, *The Amorgos Way*, with community members in the audience featured.

We also met with tourism and diving businesses to explore their role in MPA creation. They are inspired and engaged to help protect the seas that are key to their livelihoods.

Our time in Athens and Amorgos was a powerful reminder of what becomes possible when local leadership, community voices, and national ambition align. Building on the groundwork laid by the CPF and the Amorgorama partners, Revive Our Ocean — Greece aims to help expand this success across the country.

We are committed not only to creating media that inspires action, but also to delivering these stories at the right time, in the right context, and to the right audience to optimize impact.

Since our launch, we have used film, press, and social media to spotlight effective, community-led marine protection. These stories open the door for deeper engagement. The conversations that follow each screening help motivate people, address questions, and guide them on what to do next as they explore getting involved in coastal marine protection through Revive Our Ocean Collective members.

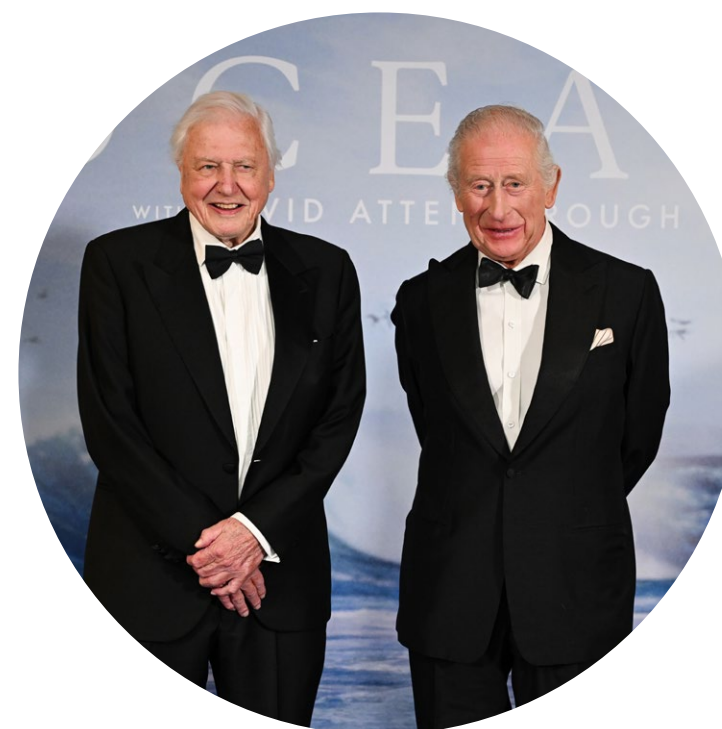
## OCEAN WITH DAVID ATTENBOROUGH: A WORLDWIDE SUCCESS

On May 6, 2025, *Ocean with David Attenborough* had its world premiere in London. With Sir David Attenborough, strong in his 99th year, and His Majesty King Charles III in attendance, it was an unforgettable evening that mesmerized the 2,200 guests at Royal Festival Hall. We were joined by leaders from across the UK and the world — many of them lifelong ocean and nature protectors, and members of the Revive Our Ocean Collective.

*Ocean with David Attenborough* tells the story of why we need a healthy ocean, how our actions are putting marine life — and ourselves — at risk, and how protecting the ocean can yield extraordinary results. It dispels myths that have perpetuated the destruction of our seas and the

livelihoods they support. One of these myths is that protecting our ocean will harm those who depend on it for a living, like fishers. But the stories that we see in the film shatter that myth. *Ocean with David Attenborough* shows us that the ocean has an extraordinary ability to recover — if we take action now.

The film began streaming on National Geographic Channel, Disney+, and Hulu on June 8, 2025, World Oceans Day. The film was produced by Silverback Films and Open Planet Studios, and also co-produced by Minderoo Pictures, Arksen & 10% for the Ocean, Don Quixote Foundation, National Geographic Society and Pristine Seas, and The Prince Albert II of Monaco Foundation.

## OCEAN WITH DAVID ATTENBOROUGH: BRINGING COMMUNITIES TOGETHER

Since the film's release, Revive Our Ocean has collaborated with our Collective members to host high profile screenings — from Athens to Lisbon to Istanbul — that bridge national decision makers with local ocean actors. In addition, in 2025 Revive Our Ocean has facilitated 271 community screenings in 52 countries to nearly 33,000 people. More than half of these screenings have included influential guests involved in decision-making.

## REVIVE OUR OCEAN SHORT FILMS

Who better to speak to a fisher about the benefits of marine protection than another fisher?

Sharing the benefits of effective coastal MPAs amongst peers in communities — from fishers to fishers, from tourism businesses to tourism businesses, and from mayors to mayors — is especially powerful: we listen best to those with whom we identify. This was the strategy and approach behind producing our Revive Our Ocean short films — to showcase the transformational impact of MPAs from those who live their benefits. Each film was created for a specific target audience: the *Heads of State* and *Mayors* films for political leaders and policymakers, and the *Fisher* and *Tourism* films for local ocean businesses plus two location-specific shorts that spotlight success stories in Amorgos, Greece, and Gökova Bay, Türkiye. Filmed in Spain, Greece, Türkiye, the U.S., the Philippines, and Indonesia, the films highlight success stories and local leadership in MPAs that deliver ecological, social, and economic benefits.

## COMMUNICATIONS REACH

In an incredibly complex and competitive attention economy, Revive Our Ocean's narrative cut through: community-led marine protection is not only possible, but also good for business. We have leveraged our voice, research, and role in co-producing *Ocean with David Attenborough* and the Revive Our Ocean short films to raise awareness and drive demand for coastal MPAs as regenerative businesses.



## TRADITIONAL MEDIA

Coverage in outlets such as *The New York Times*, *EuroNews*, *The Guardian*, *Reuters*, *TIME*, *Forbes*, and *Mongabay*, helped shape the global conversation around coastal protection, while events at the UN Ocean Conference and our country launches in Greece and Portugal brought national attention to our Collective members' work on the ground.



## ONLINE MEDIA

Online, we worked with ocean advocates, local leaders, and global influencers to amplify key calls to action — from ending bottom trawling in MPAs to supporting communities to build new protected areas.

## CREATING THE CONDITIONS FOR LOCAL ACTION

Most national policies do not allow local governments to establish their own MPAs, but require government ministries to lead the process, which makes it cumbersome, slow, and unscalable. The Philippines is an exception, which shows the power of decentralization: in the 1980s, authority over municipal waters (0–15 km from shore) was devolved to local governments, enabling communities to regulate their own fishing, create MPAs, and enforce coastal laws.

The results were transformational. Almost 2,000 locally managed MPAs were established, co-management models thrived, and decision-making became faster and more legitimate because it was led by those who rely on the ocean. This is an example of the policy changes that REVIVE will support to enable local communities to protect their seas.



# ENABLE



## NATIONAL LEADERSHIP

The opening plenary of the UN Ocean Conference in June 2025, where world leaders discussed the 30x30 target, kicked off with the premiere of the Revive Our Ocean short film featuring Heads of State leading the way in ocean protection. In the film, leaders from

Chile, Colombia, Greece, Monaco, Palau, and Seychelles relay their personal love of the ocean and how, when they took positions of power, they made marine protection a priority since it fosters prosperity and health for all.



## LOCAL LEADERSHIP

At the Ocean Rise & Resilience Summit in France in June 2025, mayors and governors from island nations and coastal cities convened to address sea level rise and chart practical solutions for community resilience. To inspire action, we premiered the Revive Our Ocean short film featuring mayors who have implemented MPAs that strengthened both local ecosystems and local economies.

Later in the year, at the Climate COP30 Local Leaders Forum in Rio de Janeiro, Brazil, we collaborated with Rare and Coastal 500 to share the Revive Our Ocean Mayors film with leaders from frontline communities around the world. The screening helped anchor the Forum's discussions with examples of mayors who have strengthened livelihoods and resilience through MPAs, giving participants a shared reference point for exploring how similar approaches could work in their own regions.

## TOOLS FOR SELF-RELIANT, LASTING PROTECTION

Once communities are inspired to protect their marine backyard, they need practical guidance on how to move forward. This includes understanding who should be involved in creating and managing a local MPA, how the MPA should be designed, enforced, and monitored over time, and how its management will be funded in a sustainable way. These questions are often complex and highly context specific, and many communities face them for the first time.

Revive Our Ocean has developed a set of practical tools, guidance, and resources to support coastal communities through each step of this process, distributed through the Revive Our Ocean Collective, helping turn local motivation into effective, long-lasting marine protection. Our approach aims at local financial benefits and independence for the people who depend on healthy coastlines for their livelihoods.



# EQUIP



## THE MPA HANDBOOK

Despite great success stories from around the world, we have lacked a singular tool or resource to learn from. While there are good manuals on specific aspects of MPAs, knowledge remains fragmented. Having an understanding of the origins, successes, challenges, financing mechanisms, and current management priorities of highly effective MPAs from around the world can help lower barriers for others in building future success, and create invaluable insights from lessons learned to guide others.

This year we co-developed an MPA Handbook, an “instruction manual” for creating and strengthening marine protected areas, with leading practitioners who have established effective MPAs, including Revive Our Ocean co-founders Dynamic Planet and National Geographic Pristine Seas. The MPA Handbook shares tried and true examples, strategies, and helpful guidance on how to assess, design, fund, manage, and sustain MPAs that support ocean health and human well-being in perpetuity.



## THE BUSINESS OF MPAs

This year, we worked closely with our Collective members to explore how their models can grow and scale in ways that reflect their local realities, capacity and ambitions. We have begun developing socio-economic analyses together as the first step toward tailored business development plans to go along with conservation plans. These efforts aim to help partners accelerate their work, strengthen financial sustainability and organizational capacity, and equip their communities and peers with pathways for scaling effective MPAs.

## WHERE WE GO FROM HERE

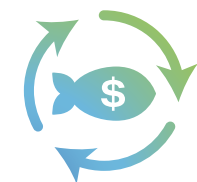
Building on the momentum of 2025, we are excited about what lies ahead as each Collective member implements and integrates the Inspire, Enable and Equip pillars of Revive Our Ocean to go to scale. In 2026, we will:



**1 Bring our MPA Handbook to life through a new training program.** Once communities are inspired to create MPAs, including through our short films and *Ocean with David Attenborough*, how will they actually do it? Our new MPA Handbook provides a strong foundation for local doers — such as fishers, tourism operators, and community leaders — to learn how to create and implement an effective MPA. Our new training program will be developed with our Collective members to ensure that the training is culturally grounded, accessible, and tailored to local realities. Through workshops, mentoring, and practical exercises, the training program will guide local doers through each step of designing, implementing, and managing an MPA.



**2 Create efficiencies of scale.** Dynamic Planet will coordinate exchanges across the Revive Our Ocean Collective to solve challenges and refine best practices together. We will continue to learn from and support each other as a community, creating efficiencies of scale for current and upcoming work. We will also be cultivating cross-sector support amongst groups that usually don't work together on an island or coastline — conservationists, fishers, tourism businesses, and different government players — who can all benefit more by working together around a shared MPA on their coast.



**3 Develop a new business model for coastal MPAs.** A traditional MPA challenge has been funding to pay for protection. Yet we know from examples worldwide that well-managed MPAs can pay for themselves. Drawing on proven MPAs, we are developing a general business framework for localization and long-term financial viability. Increased marine life inside no-take zones boosts existing revenue streams, such as ecotourism inside the MPAs and enhanced fisheries around them. Alongside access fees, these revenues can offset management costs. We're also exploring new revenue streams such as carbon and biodiversity credits. Our goal is to create a scalable model where locals benefit and reinvest, reducing long-term reliance on philanthropy and public funding.
